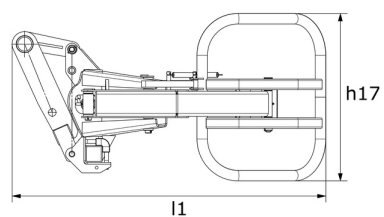
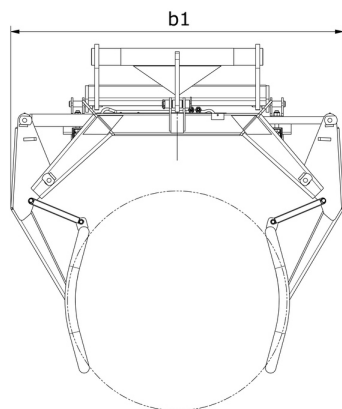
- Self-lubricated anti-wear ring that improves the longevity of the attachment.
