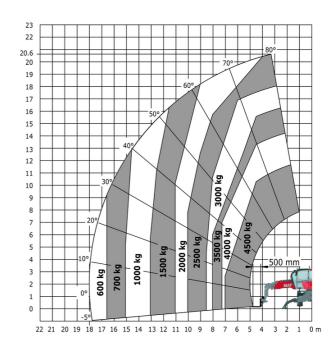

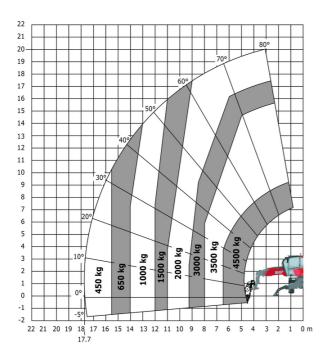



Machine on lowered stabilisers with forks Metric




Machine on lowered stabilisers with winch 5000 kg Metric

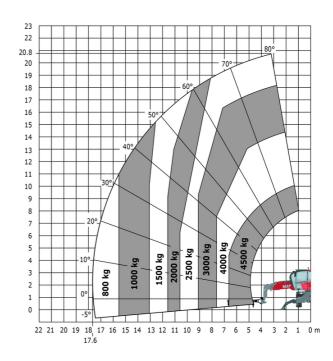
Machine on lowered stabilisers with 4000 kg jib (Metric)







