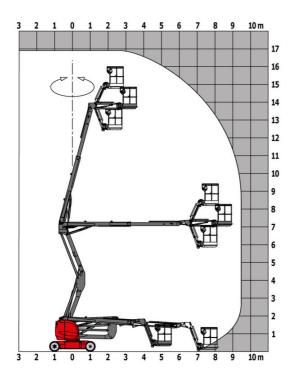



170 AETJ-L - Load chart


Load Chart metric
