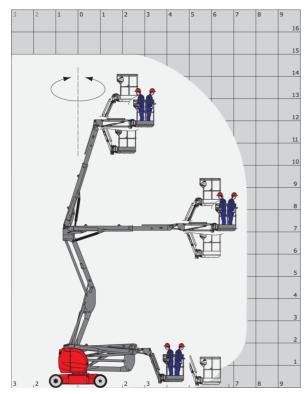




### Load Chart metric
